


VENDOR REGISTRATION CERTIFICATE

CONDITIONS OF REGISTRATION

1. This registration is valid up to **29 Jan 2025**. Please apply for renewal of registration, with request letter on the firm's letter head at least 90 days before expiry along with Latest Bank Solvency certificate, Financial Rating certificate, Copies of last 03 years Balance sheets attested by a CA, Copies of Renewal certificate from DGQA/ DRDO/ DGS&D/ DGNP/ HQENC/ CPRO/ Defence Shipyards/ Defence PSU's (if applicable) and copies of orders executed in the last 03 years. In case no application for renewal is received by due date, registration will be lapsed and name of your firm will be automatically removed from the list of registered vendors with this yard.
2. The registration renewal is for a period of three years subject to revalidation of Financial Rating up to for the period of registration.
3. Changes, if any, in address/location or constitution of the firm should be intimated to this yard, failing which your registration will be cancelled.
4. In case you wish to register for additional items, you are to apply on prescribed Performa, which can be obtained from this office.
5. Please note that as a registered firm you are expected to abide the Terms and Conditions of the contract or supply orders as amended from time to time. By the General Failure on your part to abide by these Terms and Conditions may result in the cancellation of registration.
6. Registration on the approved Vendor List of this yard does not guarantee award of the contracts/supply order or Tender Enquiry.
7. As a registered firm you are expected to quote competitive rates against ND(V) Tender enquiries and secure orders. Also, adherence to delivery schedule/completion dates is necessary. These aspects will be considered at the time of renewal.
8. Irregularity relating to security/gate pass/unfair trade practice/syndicate forming/ documents/test certificates /substandard quality etc. shall entail deregistration.
9. Holding of Registration Certificate does not entitle firm's representative for an automatic entry into the Dockyard premises. You are to follow the existing procedures for issue of gate pass etc. through the Chief Security Officer of the Yard.
10. This yard reserves the rights to cancel this registration certificate at any time during the validity period, without assigning any reasons.
11. The registered vendors are advised to address their Grievance/ suggestions/ complaints, if any, by registered post to the Manager (QA).
12. As a registered firm you are requested to comply with all Environment, Security and safety regulations in force while executing work in the yard. Failure to comply with above regulations may result in punitive action as deemed fit by the Yard.
13. If your firm has been registered on the basis of a legally tenable MoU with another firm (sub-vendor), your registration with ND (Vzg) for such specific job would be valid only as long as your MoU with the sub-vendor is valid. Further, your firm can only sub-contract the job to the sub-vendor listed in the registration certificate with which you have a valid MoU.
